Defendant.

The People of the State of California upon oath of the undersigned, upon information and belief complain against the defendant above named for the crime(s) as follows:

**COUNT ONE**

On or about September 19, 2025, at and in the County of Sacramento, State of California, the defendant, ANIBAL HERNANDEZSANTANA, did commit a felony, namely: aviolation of Section 246 of the Penal Code of the State of California, in that said defendant did willfully, unlawfully, and maliciously discharge a firearm at an inhabited dwelling house, occupied building, inhabited housecar and inhabited camper located at 400 Broadway, Sacramento, CA 95818 (ABC 10 TV Station).

"NOTICE: the above offense is a serious felony within the meaning of Penal Code Section 1192.7(c)(33) in that the defendant discharged a firearm at an inhabited dwelling."

It is further alleged that, pursuant to Penal Code Section 1203.095, there is a presumptive minimal jail time required if you are convicted of this charge.

3 It is further alleged that in the commission and attempted commission of the above offense(s),  
4 the said defendant, ANIBAL HERNANDEZSANTANA, personally used a firearm, to wit, a  
5 9mm handgun, within the meaning of Penal Code Sections 1203.06(a)(1) and 12022.5(a) also  
6 causing the above offense to become a serious felony pursuant to Penal Code Section  
7 1192.7(c)(8) and a violent felony within the meaning of Penal Code Section 667.5(c)(8).

9 **COUNT TWO**

10 For a further and separate cause of action, being a different offense from but connected in its  
11 commission as the charges set forth in Count One hereof: On or about September 19, 2025, at  
12 and in the County of Sacramento, State of California, the defendant, ANIBAL  
13 HERNANDEZSANTANA, did commit a felony, namely: a violation of Section 245(b) of the  
14 Penal Code of the State of California, in that said defendant did willfully and unlawfully commit  
15 an assault upon ABC 10 TV STATION, with a semi-automatic firearm.  
16

17 "NOTICE: The above offense is a serious felony within the meaning of Penal Code Section  
18 1192.7(c)."  
19

20 It is further alleged that the defendant, ANIBAL HERNANDEZSANTANA, used a  
21 semi-automatic firearm, within the meaning of Penal Code Section 12022.5(a) and (d).  
22

23 It is further alleged that in the commission and attempted commission of the above offense(s),  
24 the said defendant, ANIBAL HERNANDEZSANTANA, personally used a firearm, to wit, a  
25 9mm handgun, within the meaning of Penal Code Sections 1203.06(a)(1) and 12022.5(a) also  
26 causing the above offense to become a serious felony pursuant to Penal Code Section  
27 1192.7(c)(8) and a violent felony within the meaning of Penal Code Section 667.5(c)(8).

29 **COUNT THREE**

30 For a further and separate cause of action, being a different offense from but connected in its  
31 commission as the charges set forth in Counts One and Two hereof: On or about September 19,  
32 2025, at and in the County of Sacramento, State of California, the defendant, ANIBAL  
33 HERNANDEZSANTANA, did commit a felony, namely: a violation of Section 246.3 of the  
34 Penal Code of the State of California, in that said defendant did willfully and unlawfully  
35 discharge a firearm in a grossly negligent manner which could result in injury and death to a  
36 person.
